Each space Includes one table and is approximately 10' X 10' with no encroachment permitted beyond marked space. There are some 5 X 7 spaces available also.

There will be no more than 2 vendors per space and no more than 2 spaces per vending group. Members of NwRSA will be charged \$50.00 per 10 X 10 sales area and \$25.00 for a 5 X 7 sales area. Vendors must be members of NwRSA as of February 1, 2010 or will be charged the non-member non-refundable fee of \$200.00 per sales area. Selling items with the NwRSA logo requires paying 3% of the sale price to NwRSA. Manufacturers who distribute through a member may only demonstrate their product.

If your are already registered with the Sate of Washington Department of Revenue, Please contact us and we will send you the necessary short-term forms. Tax tables will be furnished to you but paying Sales Tax to the Department of Revenue is the vendor's responsibility. A temporary selling permit will be provided.

Unloading and set up time for equipment and merchandise is 9:00 AM - 7:00PM, Thursday June 3rd at the Main or Adjoining Building. Please respect your neighbor's sales booth space and do not set up displays outside your allotted space. Vendors are requested to take down and move out starting 11:30 AM and be out by 1:30 PM Sunday June 6.

Please bring a sheet to cover your table when you are not present. Your own dolly or hand truck will be a great help to keep things moving.
